

TTM Technologies 3-Day Online Auction Sale, April 2016

Important Information:

All visitors to the TTM Juárez plant must show proper I.D. to be admitted entry. All visitors crossing the border from the U.S. must provide either an Entry Visa (FMM) or Work Visa (FM3) to be shown at the gate. All Mexico citizens must show their government I.D. (Voting I.D.) TTM Security will not admit anyone beyond the guard gate without either a Visa or Mexican I.D.

BUYERS FROM USA, CANADA, ASIA, EUROPE, & ALL OTHER NON-NAFTA COUNTRIES:

REMOVAL INSTRUCTIONS / PICK UP LOCATION:

- All removals by appointment scheduled in advance to allow time for preparation of shipping and customs documents
 - Any items requiring special handling such as cranes and riggers must be picked up at TTM Juarez location.
 - For non-Mexico buyers, single or multiple lots purchased by a single buyer which do not constitute a full or nearly-full truck load, which can also be moved and loaded by pallet truck will be delivered to TTM's El Paso warehouse for pick up by the buyer
 - For all buyers, high value items, or combined purchases by a single buyer of over \$10,000.00, OR nearly full truck loads to a single buyer must be picked up at TTM Juarez location. TTM will provide a shipment pediment with prepaid customs broker fees for US import & commercial invoice for crossing the border.
 - All Freight Brokers / Shipping companies and tractors picking up in Mexico must hold a current IVA/IEPS Certification and be pre-approved before scheduling all removals. All riggers, crane operators, or other material handlers must be insured and pre-approved as well with insurance certificates naming TTM as an additional insured party.

BUYERS FROM MEXICO:

REMOVAL INSTRUCTIONS / PICK UP LOCATION:

- All Freight Brokers / Shipping companies and tractors picking up in Mexico must hold a current IVA/IEPS Certification and be pre-approved before scheduling all removals. All riggers, crane operators, or other material handlers must be insured and pre-approved as well with insurance certificates naming TTM as an additional insured party.

MAQUILA MEXICO BUYERS:

Temporarily imported assets:

- a. TTM can provide Virtual Pedimento to Maquila buyers for pick up at Juarez, MX plant. Buyers must have Custom Broker identified for Pedimento transfer.

OR

b. Maquila Buyers can pick up large equipment, full trucks of combined lots or goods over \$10,000 to export & import through El Paso border; TTM to provide shipping pediment with prepaid customs broker fees & commercial invoice

Permanent Assets / Mexican Origin Assets:

* Maquila buyers shall collect both types of lots from Juarez, MX location

NON-MAQUILA MEXICO BUYERS:

Temporary Assets:

a. TTM to make assets permanent by paying duties/fees to allow pick up at Juarez plant

OR

b. If desired, non-Maquila Buyers can pick up large equipment, full trucks of combined lots or goods over \$10,000 to export & import through El Paso border; TTM to provide shipment pediment with prepaid custom brokerage fees & commercial invoice for reimport to the US only.

Permanent Assets / Mexican Origin Assets:

* Non-Maquila buyers shall collect both types of lots from Juarez, MX location
